



Sweepstakes Rules

1. Eligibility

Weekly Summer Sunday Giveaways: The weekly giveaways will be hosted on our social media channels and will include instructions on how to enter, eligibility, prizes, and prize drawings.

6. Prize Drawing

On or about July 23, 2021, the Sponsor will select one (1) potential winner in a random drawing from among all eligible entries received. The odds of being selected depend on the number of entries received. The Sponsor will attempt to notify the potential winner via telephone or email on or about July 23, 2021. If the potential winner cannot be contacted within two weeks after the date of the first attempt to contact him/her, the winner forfeits the prize, and no other prize will be awarded in its place. If the potential winner cannot be contacted within two weeks, the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries.

7. Winner Notification

The potential winner will be notified by email, or phone. Sponsor shall have no liability for a winner's failure to receive notices due to winner's spam, junk e-mail or other security settings or for winner's provision of incorrect or otherwise non-functioning contact information. The receipt by winner of the prize offered in this Sweepstakes is conditioned upon compliance with all federal and state laws and regulations. 12. Disputes

Except where prohibited, each entrant agrees that any and all disputes, claims and causes of action arising out of, or connected with, the Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in Ventura County, California, and each entrant hereby submits to the jurisdiction of such courts. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, entrants' rights and obligations, or the rights and obligations of the Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of California, without giving effect to



any choice of law or conflict of law rules, which would cause the application of the laws of any jurisdiction other than California.
