



Sweepstakes Rules

1. Eligibility

The Sweepstakes begins on July 01, 2021, at 12:00am Pacific and ends on July 25, 2021 at 11:59 pm Pacific (the "Sweepstakes Period"). Entries that are submitted before or after the Sweepstakes Period will be disqualified. Submissions will be accepted online for the duration of the Sweepstakes Period.

5. How to Enter

Online: The Sweepstakes must be entered by submitting an entry using the online form provided on this Sweepstakes website. The entry must fulfill all Sweepstakes requirements, as specified, to be eligible to win a prize. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the Sponsor. If the potential winner cannot be contacted within two (2) days, the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries.

7. Winner Notification

The potential winners will be notified by email, or phone. Participants agree to self-monitor for signs and symptoms of COVID-19 (symptoms typically include fever, cough, and shortness of breath) and contact Sponsor if he/she experiences symptoms of COVID-19 within 14 days after participating with Sponsor. Participants may be required to self-quarantine, at Participant's own expense, before, during, or after their trip based on prevailing health guidance promulgated by the United States Centers for Disease Control, and state and local law.
