



Sweepstakes Rules & Regulations

1. Eligibility

The Canvas of Camarillo Mural Photo Sweepstakes (the "Sweepstakes") is open to legal residents of the fifty (50) United States and the District of Columbia, as well as international entrants from such countries where entering the Sweepstakes is authorized by applicable law, who are at least eighteen (18) years old at the time of entry. 5. How to Enter

The Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries.

7. Winner Notification

The potential winners will be notified by email, or phone. Sponsor shall have no liability for a winner's failure to receive notices due to winners' spam, junk e-mail or

9. General Conditions

11. Disputes

Except where prohibited, each entrant agrees that any and all disputes, claims and causes of action arising out of, or connected with, the Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in Ventura County, California, and each entrant hereby submits to the jurisdiction of such courts.
